(Revenue \$) HEAD START/EARLY HEAD START COMBINES STATE OF THE ART EARLY CHILDHOOD DEVELOPMENT RESEARCH WITH DECADES OF FAMILY DEVELOPMENT EXPERIENCE TO DELIVER INDIVIDUALIZED SCHOOL READINESS. IN THE 2018-2019 SCHOOL YEAR, UNITED COMMUNITY ACTION PARTNERSHIP PROVIDED HEAD START SERVICES TO 414 CHILDREN AND THEIR FAMILIES, WHILE EARLY HEAD START SERVED 119 CHILDREN AND FAMILIES. AN EXPANSION GRANT WAS OBTAINED IN THE SPRING OF 2019 WHICH FUNDED AN ADDITIONAL 72 EARLY HEAD START SLOTS. THE SUCCESS OF THE HEAD START PROGRAM IS BASED ON MEANINGFUL AND EFFECTIVE PARTNERSHIPS BETWEEN STAFF AND FAMILIES ON BEHALF OF THEIR YOUNG CHILDREN.

FOUR DISPATCH CENTERS ACCEPT AND SCHEDULE APPROXIMATELY 600 RIDE
